### IPSO/SIOP Meeting 2005 in Vancouver, Canada

The past IPSO meeting in Vancouver, Canada has again been a great success, with our various sessions attracting around 350 (surgical) oncologists from many countries of the five continents. More and more IPSO and SIOP progressively integrate, through which surgical speakers and surgical oncology topics become part of the SIOP meeting in the form of keynote lectures.

A well balanced program, containing key note lectures by experts in the field, symposia addressing specific tumors, and free paper sessions could be offered. Many papers of interest were presented. Again, our Program Director, Larry Hadley, comprised an attractive program with the abstracts submitted by the Membership.

The Wright Medical sponsorship was used for the WMT-Best Paper Award (this year a first and a second prize were available!), and the WMT-Best Poster Award. Again, according to many of the IPSO Membership, the competition for the prizes was felt as one of highlights of the meeting. This years winners were:

- **First prize of the WMT-Best Paper Award:** *A. Puri, Mumbai, India.* 'Rotationplasty – is there still a role?'
- **Second prize of the WMT-Best Paper Award:** *Florian Bergmann, München, Germany.* '5-ALA induced Laparoscopic Fluorescence Diagnosis of human Neuroblastoma in nude rats: a novel technique for Pediatric Oncology?'
- **WMT-Best Poster Award:** *Dariusz Polnik, Warsaw, Poland.* 'Broviac Catheter Insertion – Own Modification'

## Minutes of the IPSO Business Meeting – Vancouver, Canada, September 22, 2005

32 IPSO members were present; Apologies: Pjotr Czauderna

### **Agenda**

1. Opening at 4:40 pm
2. The minutes 2004 of the IPSO BM in Oslo, Norway, were accepted by the Membership, and signed off by the President.
3. Report from the President. No issues.
4. Report from the Treasurer. IPSO now is financially healthy. There are 14 members with outstanding dues (> 1 year). The membership was asked to help to maintain the current Membership Directory: You have to send your correct address to the Secretariat. Not receiving the bill of dues means most likely that your address is either wrong or unknown. The membership number on your bill of dues refers to your SIOP membership number; there is no IPSO membership number. The IPSO money is stored on an interest bearing account. Some of this money will be dedicated to the creation of an IPSO website. The Membership approved to spend up to E 5000 to this goal.
5. Election of EC members. Jenny Walker was elected for her second term as Treasurer (3 years), and Dietrich von Schweinitz was elected for his second term as SIOP Scientific Committee Representative (3 years).
6. Nominees Executive Council member. Roley Squir and Simon Huddart agreed to stand. Roley Squire was elected as EC member for his first term (2 years).
7. Election of new IPSO members. All applicants were accepted and congratulated by the President. The new members are:

8. President Elect. Richard Spicer was nominated as President Elect and elected by the Membership. He was congratulated by the President and he thanked the membership for their trust in his future Presidency.
9. Recruitment of new IPSO members. In 2005, IPSO had many applicants for membership. Please ask all your colleagues and fellows to join, it is of great importance to become a strong Society.
10. Future Oncology meetings. The IPSO Oncology course at EUPSA will again run in 2006 (Maastricht) and will be organized by IPSO. No financial support of the Faculty will be given by IPSO, all financial aspects of the course are taken care of by EUPSA.

The situation of the IPSO/APSA meeting was first explained by the President, then by Broecker. IPSO's goal of the combined meeting was two-fold. (1) increase the IPSO membership with USA members, and (2) increase interaction between American and European Pediatric Surgical Oncologists. Goal #1 has more or less failed. Goal #2 seems only attainable if a true combined meeting will emerge. Plaschkes explained the historical background of the combined meeting: The COG-surgeons have asked IPSO for the combined meeting, in order to improve the oncology education at APSA, after the APSA Membership expressed their wish for better oncology education through the APSA questionnaire. It should thus be regarded a COG-IPSO endeavor to have a 4 yearly oncology education session for APSA. But its costs should be budget neutral for IPSO.

IPSO will propose to the APSA Board of Governors to decide to spend every 4 years one full day

of the APSA meeting solely to Oncology. The program can be organized by the two Societies, partly by invited speakers, partly by free paper sessions. If the Board of Governors is not interested in a true mutual endeavor, IPSO will stop its offers to APSA, and will consider dedicating part of the annual IPSO program to combined IPSO-American symposia. Bob Shamberger, Rebecka Meyers, Steven Shochat, and Jerry Haase were asked to be the invited 'IPSO ambassadors' at the upcoming APSA BoG-meeting in October. They will inform APSA with a summary of IPSO's viewpoints.

11. The IPSO 2006 meeting will be held on Mon - Tues Sept 18 & 19. On Sunday Sept 17, a (multidisciplinary) Pathology meeting will be held on sarcoma, liver tumors and rare tumors, including subjects of surgical interest. Also on Sunday, a Radiological meeting will be organized, comprising interventional Radiology and minimal access Surgery, thus of great interest to Surgeons. SIOP starts on Monday afternoon. On Monday afternoon an IPSO/SIOP keynote lecture will be given. It will be named the 'Tsuchida Memorial Lecture', subjected to the 'Surgical Aspects of Neuroblastoma'. Our local Surgical Organizer 2006 (Geneva) will be Christophe Chardot.
12. PBC. No issues.
13. Any other Business. Haase summarized the discussion that took place at the EC-meeting regarding modernizing the IPSO by-laws. It was decided to start the process of changing and modernizing the IPSO by-laws, in order to have the Membership be more involved in the choice of nominees, to achieve more representation, and to create more competition at the elections. This may lead to more names of nominees from the floor, and more enthusiasm in the Membership. Hadley and Haase were appointed to make the first concept of new by-laws.

### **From the Secretary**

### **News from the Program Committee**

Especially, since this Keynote Lecture has been dedicated as the Tsuchida Memorial Lecture.

There are important symposia on liver transplantation for childhood tumours led by Prof Otte and a full day multidisciplinary radiology meeting that will precede IPSO on Sunday 17th September. Dr Roebuck has organised an exciting programme and it will be well worth making that extra day available.

There will, of course, be a session for "Problem Cases" and members are reminded to bring with them a brief (5 min) presentation on Powerpoint for inclusion. The indomitable team of Drs Broecker and Aronson will oversee this session and members should contact them at the meeting to secure a slot on the programme.

Socially, our Surgical representative Christophe Chardot has organised a gourmet experience at a convivial venue in Geneva. IPSO dinners are always worth attending!!

The Annual General Meeting of the Society scheduled for Tuesday 19th September is important to all of us as amendments to the Constitution will be discussed in an attempt to make the Society more representative and transparent. It's not only your meeting, it's your Society too!

Once again IPSO will organize an educational session within the EUPSA meeting in Maastricht in May. We hope that it will have the same success as in Gdansk, allowing IPSO to increase its membership in the future.

Finally I hope that IPSO will get its website in the next month.

Some words about our Journal, Pediatric Blood and Cancer. The Editor-in-Chief Dr Arceci presented the annual update and report in Vancouver. The number of submissions is increasing (562 in 2004, 620 annualized in 2005). Research articles represent 48% of all submissions with an acceptance ratio of 28 %. Brief reports represent 36% of all submissions with an acceptance ratio of 25%. The total number of reviewers is 500. The average time from acceptance to online publication in early view is 54 days. The average time from submission to decision is 26 days. The calculation of the Impact Factor will start in 2006, and 2007 will be the first year in which PBC eventually will have an impact factor.

Furthermore, PBC will organize a workshop in Geneva: "How to write an article".

Finally I wish all IPSO members a very peaceful, healthy and happy 2006.
